Submit the Competitive SOLICITATION, OFFER AND CONTRACT FORM up to 2:00 PM, July 23, 2026.

At that time, bids will be publicly opened. Bids received after the due time and date will not be considered.

The work generally consists of installing disaster warning sirens, poles and foundations. The siren equipment and appurtenances will be furnished by the State for the contractor to install. Sites are at various locations on the island of Kauai.

The estimated construction cost is \$500,000 and \$1 million.

All interested parties are invited to attend a voluntary pre-bid meeting.

The pre-bid meeting will be held at: Isenberg Park, 3384 Kanakolu St, Lihue, HI 96766, Tuesday, July 7, 2026, 10:30 AM.

The estimated value of the public works contract is \$250,000 or more and the apprenticeship agreement preference pursuant to Hawaii Revised Statutes §103-55.6 (ACT 17, SLH 2009) shall apply.

Campaign Contributions by State and County Contractors Prohibited.

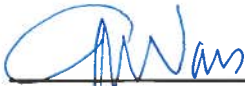
If awarded a contract in response to this solicitation, offeror agrees to comply with HRS section 11-355, which states that campaign contributions are prohibited from a State and County government contractor during the term of the contract if the contractor is paid with funds appropriated by the legislative body, at any time between the execution of the contract through the completion of the contract.

Project Labor Agreement.

In accordance with the Administrative Directive No. 24-01 (Directive), dated February 16, 2024, Project Labor Agreement for State Construction Projects; and COMPTROLLER'S MEMORANDUM NO. 2024-20, Guidelines - Project Labor Agreements (PLA) for State Construction Projects, dated July 26, 2024, a PLA is required for projects with actual award amounts in excess of one million five hundred thousand dollars (\$1,500,000). Refer to specification SECTION 00210 - INSTRUCTIONS TO BIDDERS for Project Labor Agreement requirements.

To be eligible to submit a Bid, the Bidder must possess a valid State of Hawai'i Contractor's license classification (s) **A or C13**.
